What's the job?

Reporting to the Chief Regulatory Officer/Deputy Registrar, the Director, Legislation, Ethics and Compliance (LEC) is the Department Head of a team responsible for the effective management of the investigation, assessment and resolution of complaints against individuals practicing professional engineering and geoscience in British Columbia; for the education and promotion of ethical practice; and for the interpretation and enforcement of the Engineers and Geoscientists Act of BC as well as its revisions.

As the Director, LEC you'll be responsible for overseeing the following:

- Handling of public enquiries and new complaints to determine whether there are professional conduct or competency issues for APEGBC to review
- Reviewing and analyzing complaints
- Facilitating the gathering and assessing all necessary information during the investigation of a complaint
- Exercising good judgment in making recommendations to close a complaints file or send it to the Investigations Committee
- Preparing opinions of fact and law for consideration by the Investigation and Discipline Committees or retain outside legal counsel to provide such opinions or legal advice
- Working with others to coordinate investigations
- Providing ethics, risk management and practice advice to members
- Delivering instruction courses to engineering and geoscience students or members in training on ethics
- Writing articles for various publications to raise awareness on various issues related to the work of the Department or to the professional practice of members
- Maintaining the currency and relevance of the Act and the bylaws and providing internal advice on their interpretation
- Providing staff support and advice to various committees and Council including the preparation of reports and recommendations
- Liaising with other self-regulators to share information
- Other duties as may be assigned

- A degree in Engineering, Geoscience and/or Law supplemented with continuous professional development courses as a minimum
- Currently registered as a Professional Engineer/Professional Geoscientist and/or LLB
- Minimum ten to fifteen years of related experience
- Strong Leadership skills and broad management experience
- A motivated team player with excellent inter-personal skills
- Highly organized, attention to detail
- Strong writing and communication skills
- Thorough knowledge of the Complaints handling processes for professional self-regulators
- Administratively self-dependent
