- (g) cdnpages.ca.

3. Within thirty (30) days of the Defendant's signing of this Order, the Defendant will, through the Registrar of Companies, remove the restricted word "Engineering" from the name of any company he owns or controls until such time as he obtains permission from the Plaintiff for the use of this, or any other, restricted word in British Columbia.

4. This Order will remain effective and will apply to the Defendant until such time as the Plaintiff grants him membership as a professional engineer.
