2015 APEGBC MEMBERSHIP RENEWAL INFORMATION

SECONDARY PROFESSIONAL LIABILITY INSURANCE (SPLI) PREMIUMS

Effective July 1, 2013 the National Secondary Professional Liability Insurance (SPLI) Premium is included in your annual membership fee, and will not be billed separately. Your membership fee now includes the annual premium, which is collected on behalf of Engineers Canada. APEGBC members in good standing will continue to be enrolled in the program. CPD REPORTING

Under the APEGBC Code of Ethics, members are responsible for undertaking continuing professional development (CPD) that is relevant to their practice. APEGBC's CPD Guideline outlines the association's expectations regarding the types of activities and amount of professional development that practising members should be undertaking. Compliance with the CPD Guideline and reporting of CPD activities is recommended but not mandatory.

To comply with the current CPD Guideline, members must complete an average of 80 Professional Development Hours (PDH) per year (240 PDH on a three-year rolling total.) As directed by APEGBC Council, those compliant with the CPD Guideline will be identified in APEGBC's online membership directory as "Declared CPD Compliant."

Supporting documentation (e.g., certificates, receipts) should not be submitted, but must be kept on file for audit purposes for a minimum of four years.

NON-PRACTISING STATUS

Members who wish to change their membership status to non-practising can do so via the Member Portal by selecting the "Apply for Non-practicing status" link and completing the declaration. Please note that a change in practice status does not alter the membership fee.

PRACTICE DECLARATION

In order to ensure that information used by the association and provided to the public regarding members' industry of practice and field(s) of expertise is current and accurate, all APEGBC members and/or licensees are strongly encouraged to verify and update their Practice Declaration. The information provided is used to populate the APEGBC online membership directory. To update your information, select "update area of practice" from the Practice Declaration link in the member portal at any time during the year. Members may also request a copy of the Practice Declaration form by contacting APEGBC at 604.412.4884.

THE APEG FOUNDATION

The APEG Foundation provides scholarships and bursaries to students in engineering and geoscience.
