1. The Defendant, by himself or by his servants, agents or otherwise, be restrained by an interim injunction from breaching or continuing to breach s.22 of the *Engineers and Geoscientists Act*, R.S.B.C. 1996, c.116 as amended, and in particular, that the Defendant be restrained from engaging in the practice of professional engineering, using or applying a professional engineering seal or stamp, representing himself through advertising or any other manner whatsoever as conducting "engineering", "professional engineering" or representing himself as an "engineer", "professional engineer", "P.E.", "P.Eng.", or any combination or abbreviation of such terms without being duly registered as a member or licensee of the Plaintiff, until the trial or other disposition of this action or until further Order of this Court;
2. The Defendant's approval of the form of this order is dispensed with; and
3. Costs in the cause.
