THIS COURT ORDERS that:

1. the Plaintiff is granted an interim injunction restraining the Defendant from breaching or continuing to breach section 22 of the *Engineers and Geoscientists Act*, R.S.B.C. 1996, c. 116, as amended (the "Act") until a court orders otherwise; and

2. the Plaintiff is granted an interim injunction, prohibiting the Defendant from engaging in the practice of professional engineering, representing himself through advertising or any other manner whatsoever as conducting "engineering" or representing himself as an "engineer", "professional engineer", "P.E.", "P.Eng.", or any combination or abbreviation of such terms until a court orders otherwise;
3. there is no requirement that the Defendant approve the form of this Order;
4. service of this Order be effected by delivery of a copy of the entered Order to the Defendant by regular mail at 902 - 5TH Street, New Westminster, B.C., V3L 2Y4; and
